## Terms and conditions of contract:

I accept this contract and nursery place on the following conditions:

1 Fees are payable throughout the year and exclude 2 weeks summer cleaning closure and any other week where the school is open for fewer than 2 days.

Family income and usage of place will be regularly reassessed as indicated in the contract. Families are responsible for informing the Nursery of any change in benefit status.
The fees reduction for nursery class attendance applies only during term time when the classes are open. Term time fees apply for weeks when classes are open for at least 3 full working days. Fees are payable throughout the year even when children are absent.
Persistent lateness may result in the loss of the place or additional fees.
The Council operates a "No Arrears" policy, and parents are required to pay in advance, on a weekly or monthly basis.
Non payment of fees will result in the loss of the place. Any parent who anticipates difficulties with payment should contact the school immediately.
Additional fees may be charged where fee cheques are returned to the Nursery unpaid.
Amendments to this contract can only be made through an appointment with the Headteacher and where appropriate vacancies are available.
As nursery places are in such demand the Council reserves the right to re-allocate hours that are regularly unused.
